INNOVATING LEGAL STUDIES AND PRACTICE

Are you studying the law? Have you just completed your legal studies? Are you afraid of your professional future? Are you fond of new technologies but are you convinced that law is naturally non-technological? Did you have your studies in the field of economics or new technologies and do you want to explore the technological side of the law?

The European Center for Law, Science and New Technologies (ECLT), the Department of Law, University of Pavia and Collegio Ghislieri (Pavia), in cooperation with the European Law Student Association (ELSA) and the Institute for Advanced Study of Pavia (IUSS) offer you the *Winter School Innovating Legal Studies and Practice* (Pavia 6-10 February 2017).

The reasons of the School

The Winter School *Innovating Legal Studies and Practice* (ILSP) aims to explore the ways in which *technology* is changing both the way the law is applied and the *legal professions*. The course is the result of an extraordinary cooperation between the Court of Appeal of Milan, the Milan Court, the Bar Association of Milan and the academia. Indeed, classes aim to provide participants a theoretical and practical knowledge of technological advances and an overview of theoretical implications resulting from these technological innovations.

The course provides essential tools for new professionals at the turn of the law and technology (among them, e-lawyers, legal knowledge engineers, interdisciplinary experts able to manage platforms that provide tools for lawyers and citizens).

A greater awareness and better understanding of the new crucial role of technology is a good chance to understand how the legal field is changing, and what are possible future applications of technology.

The program

The Winter School is taught in English and consists of two parts:

- a) A **theoretical Part**, which has the main goal to introduce students to law and technology, legal information, legal interoperability, transnational law and more.
- b) A **technological Part**, which focuses on practice. Each student, under the supervision of experts, lawyers and judges, will work and familiarize himself with the various innovative platforms that are already in use in the courtroom (Consolle) and law firms. In addition, they will work on the platform ALST and will experiment original solutions for legal multilingualism. In the last two days they will take part to a Hackathon: an event in which they are called to collaborate intensively in order to develop creative solutions.
